- operate with a view to prevention in the field of Health and Safety at Work and constantly carry out activities in compliance with regulations and all legal requirements
- quickly and effectively implement interventions aimed at customers and the needs arising in the course of work
- Safety Management Systems and their results are considered an integral part of company management. The responsibility for managing SSL (Health and Safety at Work) concerns the entire company organization from the Employer down to each worker, each according to his or her attributions and competences.
- constantly defining appropriate and adequate resources to achieve the objectives set in the field of Safety
